Detail of Material Information *)	<ul style="list-style-type: none">- Type of termination/closure business segment: Company processing facility located in Semarang, Central Java.- Reason for closing: Based on the letter issued by the Head of One Stop Integrated Service of Semarang City No. 503/611 dated August 2nd 2018 Regarding the response to the Proposal of Issuance of Industrial Business Permit (<i>Izin Usaha Industri ("IUI")</i>). The Company's proposal was rejected due to its location in Jl KRT Wongsonegoro No 39, Ngaliyan Semarang is designated for residential area, not for industrial area.

The impact of the transaction, information or material fact with respect to operation, law, finance or sustainability of the public company	<p>The effect to the company casued by the rejection of the IUI are as follow:</p> <ul style="list-style-type: none">- Resignation of majority of workers/ skilled workers in Semarang processing plant.- The processing plant has to stop temporarily <p>However from the financial point of view, the Company is expected to save fixed cost of around Rp 2,400,000,000 – per year.</p>

		<p>On the other hand, the Company will focus its processing and export activity in both of its subsidiaries, PT Karya Persada Khatulistiwa ("KPK") located in Indramayu, West Java and PT Nuansa Cipta Magello ("NCM") located in Makassar, South Sulawesi.</p> <p>The temporary closing of company processing facility in Semarang is also expected to have negative impact to company's export target from initial target of five (5) containers per month is expected to go down to three (3) containers per month.</p>
